I, Bhuwnesh Bansal, Practicing Company Secretary, was appointed by the Board of Directors of your Company at its meeting held on 30th May, 2023 as the Scrutinizer for the Postal Ballot & E-Voting held pursuant to provisions of Section 110 & Section 108 of the Companies Act, 2013 read with the Companies (Management And Administration) Rules, 2014, for the purposes of scrutinizing the postal ballot through e-voting in respect of below stated resolution as proposed in the Notice of Postal Ballot dated 30th May, 2023.
